- 4. The Bidding will be conducted through an open competitive bidding using a non-discretionary "Pass/Fail" Criterion.
- 5. The ILECO-1 BAC shall conduct the meeting for the Prebid Conference and Bid Opening of the Documents and Bid Offer at the given address and schedule below via videoconferencing. Authorized attendees, including representatives of bidders, who are physically present at the ILECO-1 Conference Hall, Brgy. Namocon, Tigbauan Iloilo shall likewise join the meeting via videoconferencing.

- The Submission and Opening of Bids will be on November 15, 2022 (Monday), 3:00 PM via Zoom Conference. Bids shall contain the Eligibility, Financial, Technical and Class B (if applicable) Documents, as well as the Technical and Financial Proposals prescribed in the Bidding Documents.
- 7. Representatives from each bidder/company must submit their notarized Letter of Authorization (LOA) one (1) day before the Pre-bid conference and Opening of Bids via BAC official email: <u>bac.ileco10gmail.com</u>. Failure to comply the above-mentioned will automatically mean disqualification. Only those who paid the participation fee in the amount specified per Lot shall have their bid offers opened. Bid offers received below the minimum Bid Price shall be automatically rejected.

Bidders will be advised to log in and join the BAC meeting room on which the link shall be provided to the prospective bidders before the start of the meeting.

The results of the bidding shall be submitted to the ILECO-I Head of Procuring Entity (HoPE) for final decision and awarding of BIDS. The decision of the HoPE shall be deemed final and executory.
