The ILECO I, through FY 2026 General Fund, intends to apply the sum of **Ten Million Five Hundred Eighty-Two Thousand One Hundred Forty-Five Pesos (Php 10,582,145.00) Only**, being the Approved Budget of the Contract (ABC) to payments under the contract for the Project. The period for the performance of the obligations under the Contract shall not go beyond the validity of the corresponding appropriations for the Project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in Annex “B” of NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531 (2017).
4. Representatives from each bidder/company must submit their Notarized Letter of Authorization (LOA) during the Pre-bid conference and on Opening of Bids. Failure to comply with the above-mentioned will automatically mean disqualification. Only those who have paid the non-refundable fee in the amount specified above shall be allowed to participate in the discussion during the Prebid Conference and have their bid offers opened.
5. The ILECO I reserve the right to reject any and all bids, declare a failure of bidding, or not award the contract as indicated in the National Electrification Administration (NEA) Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531 (2017) and its Implementing Rules and Regulations (IRR).

The results of the bidding shall be submitted to the ILECO I Head of Procuring Entity (HoPE) for final decision and awarding of BIDS. The decision of the HoPE shall be deemed final and executory.
